### Vogler Family Swiss Trip II, Update!!

Friday, July 12, 1996; Day 1 - Charlotte - Cincinnati - Zurich:

Assemble in Charlotte, NC; fly on Delta Flight ?? at 1625, arrive at Cincinnati, OH at 1806; leave Cincinnati on Swiss Air flight ?? at 1925 for direct flight to Zurich.

Saturday, July 13; Day 2 - Zurich: Check into hotel, rest, then after lunch board group's designated bus for afternoon city sightseeing. Dinner at hotel.

Sunday, July 14; Day 3 - Zurich - Niederhasli -Overhasli - Zurich: Visit Niederhasli (lunch) and Oberhasli. Drive north to Falls of the Rhine near Schaffhausen and German border. Return to Zurich for free time, with dinner at hotel.

Monday, July 15; Day 4 - Zurich -Chur (area)

Drive from Zurich to Chur via Rhine River. Follow Upper Rhine River west to Augustin Maissen's home town of Laax (regionally popular sesort) and possibly other scenic towns. Return to Chur and proceed south to Lenzerheide for dinner and night at hotel.

Tuesday, July 16; Day 5 - Lenzerheide - Logano: Drive southwest over San Bernardino Pass to Italianspeaking canton of Ticino and area of Locarno on Lake Lugano. Dinner and

> night at hotel in Lugano.



Wednesday, July 17; Day 6 - Logano - Locarno - Como (Italy) - Lugano

Drive to Lacarno and circle around north, west, & south ends of Lake Maggiore in Italy, cross over to Lake Como (lunch), return Switzerland & Lake Lugano area. Dinner and night at same Lugano hotel.

Thursday July 18; Day 7 - Lugano - Domodossola (Italy) - Zermatt

Drive west into Italy and proceed to Domodossola, then morth to cross Simplon Pass into Switzerland again to Brig, then Visp, then highway south to its end Taesch just north of Zermatt. Dinner at hotel at Zermatt.

#### Friday, July 19; Day 8 - Zermatt -Grimsel Pass - Lucerne

After morning cog railway to nearby Görnergrat with spectacular views of Matterhorn and other major Alpine peaks, return to Zermatt, take shuttle to Taesch, then drive back through Visp and Brig to Grimsel Pass,

thence to Brienz, then northeast over Brünig Pass to Lucerne for dinner and night at hotel.

#### Saturday, July 20; Day 9 -Lucerne - Bern - Neuchatel -Lucerne

After breakfast at hotel, drive back southwest over Brünig Pass to Brienz, then west to Interlaken and Thun, then northwest to Bern for lunch and sightseeing. Then drive west to Neuchâtel, on west shore of Lake Neuchâtel, then return to Lucerne via Biel & Olten for dinner and night at same hotel.

Sunday, July 21; Day 10 - Lurcerne - Zurich: After breakfast at hotel, drive to nearby Mt. Pilatus (possibly funicular ride to top), then circle Lake Lucerne, with lunch somewhere along the way, perhaps William Tell's town of Altdorf. Proceed to Zurich area for dinner and

night at hotel in Horgen on west hore of Lake Zurich just south of Zurich itself.

Monday, July 22; Day 11 - Zurich - Cincinnati - Charlotte: After breakfast at hotel, proceed to Zurich/Kloten Airport for day flight to Charlotte via Cincinnati.

[Our goal is a party of 30 to 45 people in order to get a price break.

Delta is a partner with Swiss Air, so the cost of flight from Charlotte to Cincinnati is part of the air package of \$1000 which includes tax

For those wanting to meet us in Cincinnati, the savings to you for the Charlotte to Cincinnati leg is only \$7.

As of November 12, the cost of the land package; which includes hotel rooms, two meals per day (breakfast & dinner), deluce motor coach, city sight-seeing, 8 lunches, train Taesch/Zermatt/Gornergrat/Taesch, and porterage for one suitcase per person (this is our limit per person), is \$1,473 based on 20 people, if we have 45 people this will drop to \$1, 250, subject to currency adjustments.

Because of the Olympic games we must start making reservations early, so by March 1, 1996, we need your name along with \$250deposit for each person. We will have to collect money this time, and then send it to Unitours. Make checks payable to Unitours, Inc for Vogler Family Swiss Trip II. First deposit of \$250. is due March 1,1996. Second deposit of \$750 is due April 1. Final deposit-cost of land packageis due May 1, 1996. Final amount will depend on number of participants (see scale) of which you will be notified.



Tour insurance is available for \$69 should you become sick and unable to go with the group. A doctor's report is required. Betty Houston will send you detailed information when you become a Vogler Swiss Trip III participant. It is firmly recommended that all participants purchase the trip insurance.

#### PHILIPP CHRISTOPH VOGLER FOUNDATION, INC.

It is my sad duty to inform you of the death of our organization's founder and prime mover, Charles McKinney Vogler, on December 1, 1995. Following a sudden collapse that morning at his home in Burlington, NC, he was airlifted to Duke Hospital, Durham, NC, where he was diagnosed as having suffered a tear in the aorta artery; all efforts to save him proved to be in vain. A funeral service was held for him at the Front Street United Methodist Church in Burlington on December 4, with interment later that afternoon at Forsyth Memorial Park in Winston-Salem, NC.

Fully half his life had been dedicated to family history research and publication, a project that bloomed far beyond his own expectations when it became possible to trace not only Philipp Christoph Vogler's American and Canadian descendants but his hitherto unknown Swiss and German roots as well. As we mourn his passing, we can nevertheless celebrate his life as one of remarkable achievement and personal fulfillment, while we honor him for having been able to reach out and touch the lives of many hundreds of us who will remain in his debt for having revealed to us our common family bond. For without him our broad family identity would never have been defined so clearly and so permanently, thanks to his extraordinary organizational skills and technical expertise. At this point, those of us serving on the current Board of Directors will do everything in our power to maintain the Foundation and its projects, as he would have hoped. To do so will require the active support and participation of as many of you as possible in the weeks, months, and years ahead. Please join us in this mission, the best possible way you can honor the memory of our kinsman, friend, and benefactor Charles Vogler.

On behalf of the Foundation and its members, I offer his wife Rachel and all their family our heartfelt condolences at this sad time for them and for us.

Before his death, Charles Vogler had been able to finish making all essential group travel arrangements for the Summer 1996 trip, described in his November Newsletter and later adjusted to begin with departure for Switzerland on Friday, 12 July 1996. with return now scheduled for Monday, 22 July 1996. Since the trip is now set up, we will need to know right away just who of you can provide a firm commitment to participate this summer. Our GO / NO GO decision will have to be made by March 1, 1996 at which time a \$250.00 deposit per person would be due, payable to Unitours, Inc. and sent to Charles' sister. Betty Vogler Houston, who has agreed to serve as trip coordinator (as she did for the highly successful 1992 Swiss Trip I) and who should be contacted at 5000 Addison Drive, Charlotte, NC 28211 (tel. 704-366-7440). At this writing, air fare will be approximately \$1,000 and land cost will be approximately \$1,473.00 (subject to a currency adjustment) for 20 participants. 25 participants, \$1,401.00; 30 participants, \$1,354.00; 35 \$1,320.00; 40 \$1,267.00; 45 \$1,250.00. Single supplement add \$212.00. (Less than 20 participants, trip will be a NO GO and deposits will be returned to you).
