We depart Charlotte Aug. 8 on Delta Airline at 3:10pm, arriving in Atlanta at 4:25pm. From there we board SwissAir at 5:30pm with arrival in Zurich at 8:15am. We will return from Zurich via Atlanta on the 18 of August arriving back in Charlotte at 4:18pm.

You and your friends have time to join us if you act now. We are traveling on a quote based on 15 travelers. **The cost of the land trip is \$1,410.00 based on double occupancy** (Single Occupancy supplement is \$181.00 extra). If we are able to secure 20 participants the land portion drops to \$1,236.00. **The Airline Cost is \$1,141.00** with no significant savings for additional travelers. If you have frequent flier miles and handle your own ticket you may join us in Zurich for the land portion. Included in the \$1,141.00 air cost is a 39.00 tax charge. There is no extra tax on the land fare.

You already have our travel itinerary updated and sent to you last fall. Since then we have added a trip to the **Castle of Chillon** as well as a tour of Geneva. All meals are included (except for 4 lunches), private motor coach & driver sightseeing guides, tickets, and a train ride for spectacular views of the **Matterhorn**, and portorage for one suitcase per person. A special lunch will be prepared for us and 6 Swiss guests on the Sunday that we visit our **"Home Church" in Niederhasli**.

We give special recognition and thanks to our leader, **Fred Vogler**, who guided us through our first trip and has graciously consented to be with us in '97. Fred, you make our trip very special because of your knowledge of our homeland and your willingness to share it with us. We also give special thanks to our **Trip participants**. You make the trip possible! We will be making memories that will last a lifetime.

## PCVF, Inc.: a Brief Look at Where we Stand, Where we are Going, and How do we Get There.

Our Philip Christoph Vogler Foundation, Inc. is very much alive and active, continuing on into the future, just as it's founder Charles Vogler planned it. The following will bring everyone up to speed on where things stand today and what has been happening during this past year.

1) The database of members that Charlie had so well developed and organized, is on its way back to where it needs to be. We have gone back and cross referenced original entries to the ledger books as well as looking at old files. The decision was made to work with a system that we all understand, so several people will be involved in the collection and execution of database information. We will have updated dues listings on our next newsletter addresses. There are plans to form a *computer committee* ( which would be open to all interested members) to help with information gathering, processing and the disbursement to the Foundation; more on that at a future date.

2) All books (which are completely documented and numbered) are sold except for two of the original number. Seven defective books were sent back to the publisher who replaced two with their new samples (already sold) and rebound the other five (2 already sold). See ad on page 4 of this newsletter for information about ordering these last volumes.

3) Operating capital is generated primarily from membership dues. These dues have remained the same for years even though the cost of publication and distribution has increased. Due to this fact, beginning in 1998, only members who have paid their dues will receive the newsletter. This will help the Foundation cut costs with printing and postage. We also have several members who have given of their talents in order to help the Foundation financially by donating a portion of sales from items relating to the Family back to the PCVF, please see the listing in the back of the newsletter.

4) Family Lawyer, Charles Bateman is on the Board of Directors to advise the Foundation and to help us pursue non-profit status which was initiated by Charles Vogler several years ago. The original By-Laws and the organization of our Foundation are being directed toward that purpose. This will take time!

5) Debbie Vogler Pendleton, Charles and Rachel's daughter, has been our Artifact Keeper from day one. Charles' records are hers to pursue the future book that Charles had in mind. All information concerning the family should be channeled to her. Information concerning that committee will be forthcoming.

6) Newsletter Editors Steve & Cindy Vogler Smith, son in law and daughter of Charles & Rachel, are trying to juggle 3 kids, two careers and this newsletter. We will be in touch more often, as it looks as if we have solved the problems with the addresses. Please continue to forward newsletter info to us. 7049 Avenbury Circle Kernersville, NC 27284.

7) Plans for upcoming PCVF Reunion in 1998 or '99. Nancy Vogler Bateman will be helping with arrangements. More information as it becomes available.

8) The PCVF, through the Board of Directors and represented by Frances Vogler is still looking for a lasting way to honor the founder of the Foundation: Charles M. Vogler. Several ideas have been brought forth yet as to date no decisions have been made or even aggressively pursued. If you have any ideas please feel free to contact us.

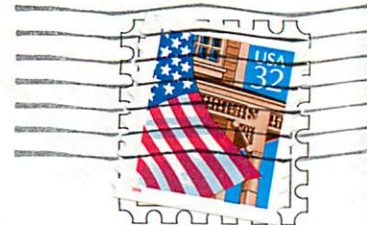
