THE NAME WAS CHANGED TO PHILIP CHRISTOPH VOGLER FOUNDATION, INC. IN JUNE 1994.

The Philip Christoph Vogler Foundation is made up of people not unlike yourself. We all work, have families to care for, soccer games to watch our kids play, and have an appreciation for those who came before us. The Board of Directors are made up of people who volunteer their time in order

to preserve the history of the Vogler family name. We do this with the hope that we can interest others to want to get involved in learning and discovering more about our ancestors. Dr. Fred Vogler for example, with the help of Mr. Edward Cooper of Texas, has found a genealogist best friend in Mr. Werner Kaag of Remchingen, Germany. Mr. Kaag, in looking at the background of Anna Catharina Seitz, Philip Christoph's first wife, found written confirmation of the actual date of Philip Christoph's birth and had actual church records from 1723 photocopied to offer proof. This is significant in that we now know the date; a date which is two years earlier than the Moravian Archives has on file. Fred wrote an article in the January issue of the newsletter outlining the entire collaborative effort in obtaining information from Werner Kaag.

I mention this only to show the power of people who care strongly about a cause. Our group of part time genealogists is able to help the Moravian Archives in Winston-Salem to improve the accuracy of their records. **We need more people to join our organization and get involved.**

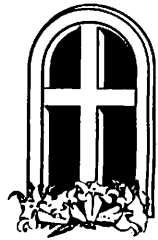

PHILIPP CHRISTOPH VOGLER'S YOUNGER SISTER'S
GERMAN AND AMERICAN DESCENDANTS
NOW KNOWN TO US**

Message from Fred Vogler, European Historian

Last year (2000) we were pleased to report how our German friend Werner Kaag had managed to trace the German family of our immigrant ancestor Anna Catharina Seitz Vogler (Philipp Christoph's first wife) back seven generations from her own. Since the beginning of this year (2001), we have unexpectedly been able to establish contact with an American descendant of Philipp Christoph's sister Maria Catharina, born in Gondelsheim / Baden on September 23, 1724, seventeen months after her brother's own birth. Up to this point, we knew nothing about her except the fact of her birth, as was the case with her younger siblings as well, all having been left behind when her father Hans Georg Vogler and her older brother Philipp Christoph left by themselves for North America in 1742.

Thanks to a helpful referral provided by our cousin Edward Cooper of San Antonio, TX (who also put us in touch with Werner Kaag in Germany last year), we have been in correspondence with Mrs. Suzanne Hiller Bullock of Mechanicsville, VA. She recently discovered her direct family connection with us as our cousin while doing research at the LDS Family History Center in nearby Richmond. In addition, she has been able to establish that in 1752 her ancestor Maria Catharina Vogler was married in Heidelberg / Baden (about three miles north of Gondelsheim) and lived there from then on, as did her descendants for the next 170 years or so until Suzanne's Hiller grandparents decided to emigrate to the United States not long before World War II. Suzanne has even visited that immediate area of Southwest Germany herself and was able to establish contact with close relatives still living in Heidelberg itself as well as in or near Karlsruhe, the former state capital some 15 miles to the southwest.

During that 3-week family reunion in Heidelberg several years ago, she even had occasion to drive through Gondelsheim on her way to a social event in the next town south. Ironically, at that time she had not yet discovered her Vogler connection and so was unaware of Gondelsheim's significance for her own family's history. Equally ironically, when our Swiss Trip I group left Gondelsheim after its memorable Homecoming pilgrimage there in May 1992, our tour bus then passed through Heidelberg on our way north to the next stop at Heidelberg and its castle. Like Suzanne Bullock, we had no idea of the significance of that town for us as we hurried through it on our way elsewhere. Luckily, both she and those of us who participated in Swiss Trip I now do know what those two towns have meant for our family, and those trip memories are much richer as we look back at our experience in common.

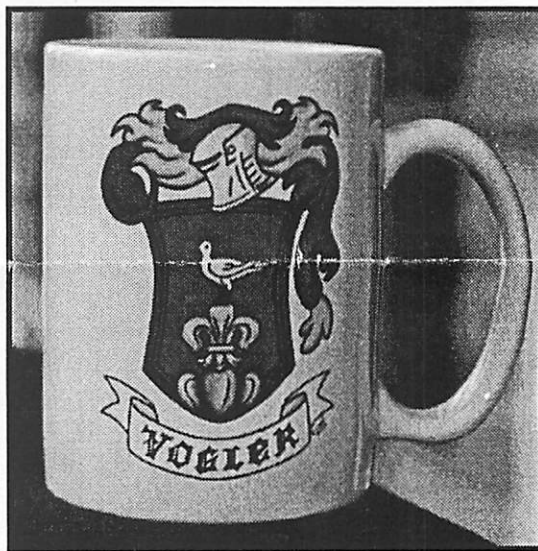

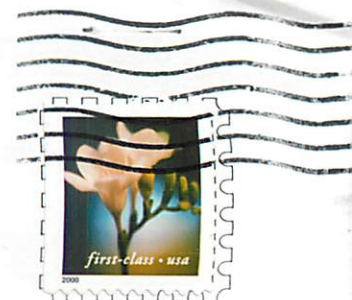

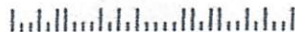
