"New" Side of PCVF & Old Salem To Be On Display

The festivities will kick off Friday afternoon with a Vogler family golf tournament; format to be determined. Saturday, the reunion meeting room at the Hawthorne Inn will be filled with activity from family musicians, displays of family history and interests, Vogler vendors offering their talents in art, crafts, as well as the new installment of the Vogler Collectable coffee mug. Children's activities are being planned as well. The wee folk are guaranteed to learn about their history through a program of games and toys geared toward their interests. # ANOTHER FAMILY HISTORY BREAKTHROUGH: PHILIPP CHRISTOPH VOGLER'S MAVERICK FATHER

Up until a few months ago, it had never been known just why 19-year-old Philipp Christoph and his 44-year-old father Hans Georg Vogler chose to set out by themselves for North America from what is now southwestern Germany, leaving behind them forever Philipp Christoph's brothers, sisters, stepmother, and 4-year-old half-sister in their home town of Gondelsheim near Karlsruhe. But now, thanks to the curiosity and initiative of our devoted German friend and helper Werner Kaag, the reason for their departure appears to have been convincingly established.


Having previously worked only with old German church records in tracing the genealogy of our Vogler and Seitz ancestors, by chance Werner came upon early 18<sup>th</sup>-century civil government records for the Gondelsheim area. And, to his amazement (and to ours), he discovered that over a period of fifteen years beginning in 1727 and continuing until his 1742 emigration, Hans Georg Vogler had been systematically monitored by town authorities as one of a group of seditious troublemakers (sometimes referred to as "rebels") who refused to accept the authority of the local feudal overlord but instead supported his rival in claiming jurisdiction there in Gondelsheim. As evidence of this long-lasting situation, Werner has sent us a initial set of 76 photocopied pages from various town records, on each of which Hans Georg's name appears in an unfavorable context as part of a group being watched as disloyal and potentially dangerous.

No wonder that after 15 years Hans Georg decided to accept a "sweet deal" that happened to come along at that time, allowing him to resettle in Maine under what appeared to be attractive conditions for himself and his eldest son, even if no one else in his family accompanied them. As far as we modern descendants are concerned, it now appears likely that it was not primarily out of frustration at being part of a still unassimilated Swiss German minority in town (even though born there) that Hans Georg decided to leave, as I myself had come to assume. Instead, after 15 years he was probably thoroughly exasperated at being tagged officially as a political maverick who needed to be watched constantly with others as being a threat to the local overlord's authority there in Gondelsheim.

And of course, as later events would prove, his son Philipp Christoph would be no "yes-man" either, with conversion to the Moravian Church and removal of his family from Maine to North Carolina to be the most important decisions of his own mature life.





## Timothy Vogler Gun Shop Opens To Great Reviews

Private Ribbon Cutting is Attended by Several Family Members






imothy Vogler would be quite pleased with what occurred at Old Salem on August 10, 2002. The 11:00 AM ribbon cutting ceremony opened his restored shop. This is now the oldest, most authentically restored gunsmith shop in America. The ceremony was attended by several members of the PCVF, Inc. Board as well as local dignitaries and financial contributors. Mr. Henry Carter, Chairman, Old Salem Board of Trustees opened the festivities. A descendant of Timothy, Mr. Mosby Vogler then spoke about the importance of the project. The ribbon cutting was performed by Mr. Carter, Mr. Mosby Vogler, and Mr. Norwood Robinson, Trustee of RJ Reynolds Foundation (a major financial contributor to Old Salem).

Following the ceremony, all invited guests attended a special luncheon in the MESDA auditorium. The luncheon featured

several special speakers. Mr. Paul C. Reber, President of Old Salem, welcomed all the guests and invited everyone to tour the "New Visitors Center" which is still under construction. Once completed, it will be the largest and most modern "visitors" and learning "centers" of it's kind in the US (it will be open for our reunion next year). The activities continued through the day with rifle firing demonstrations, tours of the shop and other buildings at Old Salem. All in all, it was a very special day for the Vogler's of Old Salem, and again we see the important role our family played in the success of this historical village.

The shop will be staffed by, Mr. Blake Stevenson, Gunsmith, Mr. Nathaniel Norwood, Director of Historical Trades at Old Salem, and Mr. Ryan McNaab, noted gunsmith and advisor to the shop. Actual replicas of the Timothy Vogler long rifles may be ordered through the shop. They will be produced using the same tools and methods Timothy developed to produce his famous trademark rifles. The shop will spend the next several months getting tooled up in preparation of the actual manufacturing of the rifles. The work today is being done much as it would have been done in the mid 19th Century, with blacksmithing handling all of the aspects of getting a shop prepared to manufacture.

This truly is a great exhibit and learning attraction. This is *our* family and *our* tradition that will come to life again through the gunsmiths of Old Salem. Each of us needs to make this a stop on our next trip to Old Salem. For those of you outside the area, it is an attraction you will enjoy next summer as part of the reunion celebration in July. Mr. Blake Stevenson has accepted an invitation to be part of the evening activities of July 18.
